GENERAL ASSEMBLY MEETING and visit to the

Textile Museum



he General Assembly Meeting of our organization took place on March 21, 2013. It was a pleasant afternoon during which we reviewed the accomplishments of 2012, and we also toured the museum at the Center for Mayan Textiles (Centro de Textiles del Mundo Maya), located at the ex-Convent at the Santo Domingo Church (Templo de Santo Domingo, where the large outdoor textile market is held daily). Our event started with a guided tour of the second story of the textile museum, where there is a magnificent collection of Chiapan textiles. The tour was followed by our annual General Assembly Meeting in the museum's artisan training room, attended by about thirty of our members and donors, as well as various representatives from beneficiaries and recipients of Amigos donations, such as Chantiik, 12 Guayacanes, Melel Xojobal, and Banco de Alimentos.

During this event, some members took advantage of the opportunity to renew their annual memberships.



Amigos President, Hileana Garcia, welcomed our guests and reviewed the activities completed during 2012 and the projects that Amigos will support with grants in 2013.

Among the fundraising events last year, mention should be made of the Annual Members Meeting, held in January at Casa Felipe Flores, where we raised M\$12,587 pesos (U\$1,007 dollars); the Sak Tzevul concert, at La Casa del Pan, where M\$4,350 pesos (U\$348 dollars) was raised; the short film "Amigos: Making a Difference in Chiapas" presented in November, at the Plaza Real restaurant; and the successful annual Amigos Flea Market, held in December, where we raised M\$19,253 pesos (U\$1,540 dollars).

The projects that will benefit from Amigos funding in 2013 are dedicated to health, education, and economic development among the disadvantaged and at-risk population. The organizations that Amigos will give grants to this year include:

Chantiik: The grant will cover self-esteem workshops, gender equality, and prevention of at-





risk street-youth.

La Casa de Flores: To pay for the salary of a fulltime teacher for the children.

Melel Xojobal: To partially cover the salary for of an educator to work with the children.

Colectivo Educacion para la Paz y los Derechos Humanos (CEPAZDH): To produce a 10-minute video and radio spot-announcements about human trafficking and children abuse in Chiapas. The organization will establish alliances with local organizations for outreach to the general public, promoting this prevention campaign in the media, and presenting discussions in schools to raise awareness among students and parents.

Banco de Alimientos de Los Altos de Chiapas, BACH (Chiapas Highlands Food Bank): To cover the wage of a nutritionist in charge of directing the training of local families –reaching more than 7,000 family units– with the objective of preventing general malnutrition.

Hogar Comunitario Yach'il Antzetic (Community Home Yach'il Antzetic): To cover the costs of food and lodging that will enable 20 women to temporarily reside in the Home during their pregnancy and the birth of their child. **12 Guayacanes:** To develop a new project in fish production and the installation of security lighting for the outdoor exhibit/demonstration area.

Mujeres y Maiz – Comedor "La Milpa" (Women & Corn – "The Cornfield" Dining Room): To ensure adequate nutrition for 10 students who will eat at "La Milpa" and thereby support the training of disadvantaged women in business skills.

The Financial Report was presented by Yatziri Zepeda, Director of Amigos, as was the explanation of goals and objectives for the 2013-2014 fiscal period. Yatziri also introduced the new Administrative Coordinator, Beatriz Álvarez, who assisted with the logistics and registration of the event.

A few testimonies

o show the progress of some projects awarded grants by Amigos in 2012, we asked the organizations to send us a short story about a person benefiting from their Amigos grant. We believe this is the best illustration of the program's support and its effectiveness.

BANCO DE ALIMENTOS DE LOS ALTOS DE CHIAPAS AC (BACH)

raciela Gomez Valazquez lives in the neighborhood Relicario and her testimony relays the joy she feels for the help received from BACH.

"They really help me so that I can get groceries because I have two children that I like to send off to school with a good breakfast or snack, which, really, if I were to try to buy it it would be out of my reach financially."

Graciela also told us that BACH sometimes brings shoes and other items such as clothing or dish soap. The part of the training and awareness is also very important for Graciela:

"The workshops that they teach are very nice. They teach us how to eat healthy food, they weigh us, they give us brochures to read so we can be vigilant about whether we are in good health ... On the other hand they also teach us to sow carrots, tomatoes, peppers, onions and lettuce. The truth is I am very happy because I feel useful, a part of the collaborative efforts of the Food Bank volunteers."

Boniface is an elderly lady and she was not finding a way to feed her family because, according to what she told us, everything is very expensive; but with the support of Amigos de San Cristobal, she can produce vegetables, mushrooms, chicken and fish with her peers and companions. "Now I have food and can

With the installation of lights/electricity –one of the benefits of the project– I am no longer afraid to remain at my friends' houses during the night. I feel proud as we are an example to our community and our region."











his organization sends us the story of Angelica*, a 16-year old girl who participates in the "positive self-worth workshops, and the risks of the street and gender".

The girl always walked very close to her older sister as they went out each day to offer their crafts through the streets of San Cristobal.

If some interested clients approached, Angelica always tried to hide behind her sister, hoping that they wouldn't speak to her and she would never look up from the ground. One day they were invited to learn sales and bartering in an organization that they know and trust. They are able to grow in their capacity to learn, and with the support of Amigos de San Cristobal, to work with regard to their feelings, emotions and rights.

People know Angelica now, she smiles and greets them with her chin high, knowing that as an individual she is valuable and able to dream and to work to achieve those dreams.

ernandez Gomez has a family of four children and their mother. He is a native of San Juan Chamula and arrived in San Cristobal seven years ago. Until 2012, none of them attended school. With the help of Melel Xojobal, the mother was able to process and obtain their birth certificates, which are essential

for entry into the school system. In addition, two of his sons and his daughter (who receives a scholarship) have entered elementary school, where they attend classes in the afternoon. They continue to work. In the morning they make their crafts and between seven and midnight sell them in the city center.

Many thanks to "Project Fortalece" for legal and tax advice. Participated in the workshop several organizations in Chiapas. migos recently received a grant that has enabled us to receive advice in obtaining tax-exempt status. This will allow Mexican donors to claim their donations to Amigos as taxexempt.The process is being carried out by students at the University Iberoamericana under the supervision of Lic. Angeles Anaya. Through this process the law students will learn the legal and fiscal framework

for Philanthropy and Social Investment and in the future will be able to advise other non-profit organizations. The process is helping Amigos continue along the path of becoming a well-organized and well-managed institution. We believe that the legal process is the last part of a process of institutionalization solid and well made.

CELEBRATING

485 years of the foundation of San Cristóbal

his year 2013 marks the 485th anniversary of the founding of San Cristóbal de Las Casas. The city was founded on March 31, 1528 by Captain Diego de Mazariegos, and was one of the first settlements in the Latin Americas by the Spaniards. By order of King Charles V, it was named Ciudad Real. It was built on a marshy valley

wilderness that the natives called Gueyzacatlán- the place where the grass grows high. The city was laid out according to the model city of Ciudad Real, Extremadura, in the ancient kingdom of Castilla La Mancha, Spain, with its main church in the central square plaza. Through the years, the city has held various names.

The city's present name

was given in 1829 in honor of San Cristobal Mártir, protector of travelers and in 1844 de Las Casas was added, in memory of Brother Bartolome de Las Casas, the first Catholic bishop who arrived in Chiapas. The is why "Las", is written with the capital "L". It was the capital of the Province of Las Chiapas from the colonial era until the mandate of Governor Emilio Rabasa (1891 - 1894), when for political reasons, he then removed the government of the state to Tuxtla Gutierrez, unleashing a fierce rivalry between the two cities that ended in a fratricidal armed confrontation.

Today, San Cristóbal is a cosmopolitan city considered the main tourist resort of Chiapas and is included in the "Magical Cities" program by the Secretary of Tourism in Mexico; its architecture

and cultural traditions have made the city worthy of this distinction.

The city also witnessed the passage of various cultures that have decided to settle and form a multicultural amalgam that is enriched day by day. Tzeltales, Tzotziles, Lacandones, Tojolabales, Chiapanecos, Mexicanos, Europeans, Asians, North Americans; today we are all part of this merging of cultures that come together in this great city
